SHEEP – CATTLE DOWNS

Sheep-Cattle Downs is a self-regulating dry season lick specifically formulated for adult sheep or weaner cattle (>100 kg LW), grazing Mitchell Grass Downs country or on heavier black soil.

Sheep-Cattle Downs contains Monensin Sodium "For improved feed efficiency" and "prevention and control of coccidiosis due to the protozoan *Eimeria bovis* and *Eimeria zuernii*".

Daily intakes:

Animal Class	Grams per day
Weaner – 100 kg LW	175
Weaner – 150 kg LW	350
Adult Sheep	40-60

Feeding guidelines:

- Do not feed to starving stock and ensure that stock have access to adequate roughage in the paddock and a plentiful supply of fresh water
- Ensure troughs are self-draining to prevent product spoilage and ammonia toxicity due to water pooling in the event of wet weather
- Ensure stock have access to a consistent supply of product for supplement to be effective, economical, and safe. In the case the trough becomes empty, add a layer of salt, and monitor intakes
- Place troughs at a 200-300 m distance away from water points

Ingredients:

- Vegetable protein meals, salt, pulverised limestone, urea, mono-dicalcium phosphate, sulphur, ammonium sulphate, molasses, monensin sodium, trace minerals and vitamins A, D₃ and E
- Ingredients and analysis may vary due to seasonal availability and conditions

Storage:

Store in a dry place under cover and out of direct sunlight.
